


Reach Conformity Declaration





Reach Conformity Declaration

REACH stands for the Registration, Evaluation, Authorization and Restriction of Chemicals.

REACH (EC 1907/2006) aims to improve the protection of human health and the environment through the better and earlier identification of the intrinsic properties of chemical substances. This is done by the four processes of REACH, namely the registration, evaluation, authorisation and restriction of chemicals. REACH also aims to enhance innovation and competitiveness of the EU chemicals industry.

Roles under REACH

DYCONEX neither manufactures nor trades in chemical substances. As such, we are subject neither to registration requirements nor the obligation to issue safety data sheets.

Printed Circuit Boards are classified as Articles under the REACH regulation 1907/2006/EC. The role of DYCONEX is therefore considered a "downstream user".

Duty of communication

According to REACH, Art. 33, suppliers are obligated to inform DYCONEX immediately, if their delivered products contain any of the <u>SVHC substances</u> (Substances of Very High Concern) in concentrations higher than 0.1% w/w. For its part, DYCONEX will notify its customers immediately upon receipt of any such information, if the delivered DYCONEX PCBs contain <u>SVHC substances</u> in concentrations higher than 0.1% w/w.

Even so, DYCONEX is in constant contact with its suppliers. In this regard, it requests obligatory information as to whether or not there have been REACH-relevant changes in connection with the chemical composition of individual raw materials.
